

"We are also demanding an increase in the amount paid under the voluntary separation scheme (VSS) offered by the management. The company is offering between Rs 8 lakh and Rs 10 lakh as VSS. Most employees here have been working with the company since the beginning and they should be given Rs 30 lakh as one-time settlement amount," he said.

Earlier this month, the GMEU submitted a memorandum to the Vadodra Collector, seeking intervention. "Employees are also demanding that the new company
